Observed the following nonfood-contact surfaces of equipment throughout the establishment in need of cleaning:

- 1) Excessive coffee grounds and hot chocolate powder inside Starbucks coffee machine (see attached photos).
- 2) Interior cavity of microwave, including door, is soiled with encrusted food debris (see attached photo).

Correct as soon as possible by cleaning nonfood-contact surfaces of equipment to sight and touch on a regular basis to prevent harborage conditions and accumulation of food, debris, and other contaminants.
