- 1) Interior microwave cavities are soiled with excessive amount of encrusted food debris/residue/splatter, specifically along side walls and ceiling (see attached photos).
- 2) Interior of cold-holding unit has food debris along bottom surface (see attached photo).

Correct as soon as possible by cleaning nonfood-contact surfaces of equipment to sight and touch on a regular basis to prevent harborage conditions and accumulation of food, debris, and other contaminants.
