Walk-in cooler fan guards have clinging debris/dust accumulation, which can be a potential contaminant in uncovered foods.

Correct as soon as possible by cleaning nonfood-contact surfaces of equipment to sight and touch on a regular basis to prevent harborage conditions and accumulation of food, debris, and other contaminants.

Closing Comments:

Core violation shall be addressed/corrected as soon as possible, which will be reinspected at the next routine inspection.
