Observed multiple PH/TCS foods, including "chickpea salad wrap" and "salami & cheddar snacker" (located inside standing one-door reach-in cold-holding unit), with "best if used by" dates of 6/16/2024 and 6/14/2024, respectively (see attached photos). In addition, light is blinking red on door locking mechanism, however customers are still able to access this cold-holding unit.

Correct immediately by discarding any PH/TCS foods that are beyond 7 days from preparation date or if they exceed the listed expiration date/time.

6/17/2024 Nonfood-contact surfaces of equipment shall be cleaned to sight and touch on a regular basis to prevent harborage conditions, and accumulation of food, debris, and other contaminants.

Observed the following nonfood-contact surfaces of equipment throughout the establishment in need of cleaning:

1) Interior microwave cavities are soiled with excessive amount of encrusted food debris/residue/splatter, specifically along side walls and ceiling (see attached photos).

Correct as soon as possible by cleaning nonfood-contact surfaces of equipment to sight and touch on a regular basis to prevent harborage conditions and accumulation of food, debris, and other contaminants.

Closing Comments:

Follow up needed to address/reinspect priority violation 3-501.18.

Area is under surveillance 24/7 without employees, therefore no signature obtained. Routine inspection report was emailed to Joe Sak, Dominic Noto, Jeremy Kinney, and Andrew Plets (Market Twenty 4 Seven) on 6/17/2024.
