THE REQUIREMENTS WERE THOROUGHLY DISCUSSED WITH STAFF AND MANAGEMENT DURING THE INSPECTION. ALL AGREED THAT A FOUR HOUR TIME STAMP IS NEEDED FOR THE COLD BREW COFFEE. UPON REQUEST THE COFFEE WAS THROWN OUT AND A NEW BATCH WAS PROVIDED WITH A FOUR HOUR TIME STAMP. VIOLATION CORRECTED.


